## **TODAY'S SPEAKER**

Ann MacAffer

CBRE

Ann worked with Chuck Shank to move his offices to a new building and it's been challenging. Chuck has been having issues with the air conditioning in the new office. Chuck now has an attorney involved because the landlord has not been working to rectify the problem. As the leasing agent, Ann represents Smith Brothers and works on their behalf.

Hurk's Garage at Madison Ave. and Jefferson St in Albany is an interesting property that Ann is working on selling. The business is well known in the Corvette world. It's a historical property and is filled with automotive equipment and parts that would have to be moved out.

500 Federal St. in Troy is fencing in the parking lot because it has been leased to the film crew for the Gilded Age.

Several small local restaurateurs are looking for space in Troy.

Warehousing is slowing down in the area, with less companies leasing and also people taking smaller spaces. The average size went from 1400 to 900. This results in more available warehouse listings.

In the office market, Ann currently has two law firms looking for space in downtown Albany and one in Troy.

In New York, when a building is sold the lease typically goes with the sale.

People have been taking one, two and three year leases on coworking space.

Coworking warehouse space is also available for companies that only need a small warehouse space. Ann is not sure how secure it is, since there is no ceiling directly over the individual warehouse space.

The 169 State St. building was lost to the bank.

Ann has five buildings on Aviation Rd. coming up for lease.
