TODAY'S SPEAKER

Sean Howley 1st National Bank of Scotia

As a fraud specialist, Sean said that banks often find fraud after the fact, so he wants to help customers protect themselves against fraud.

If fraudsters are able to get a piece of your personal information they will probably be able to get enough additional info for them to open accounts and take out loans.

One of the most effective tools the bank offers is alerts. There are many different types of alerts that bank customers can enable for their account protection.

While retailers have 60 days to file a fraud claim, small business owners have only 48 hours, so finding fraud in a timely manner is important.

Stolen money goes into a web of accounts and is not easily recovered. The onus falls on business owners to protect themselves against fraud, and the bank provides them with tools to help them. The fraud specialist can educate business owners to help them put safeguards in place.

Online security tools provide a second set of eyes to verify that money leaving an account is a valid transaction.

Business owners can set up alerts and tools that enable them to approve transactions from their mobile phones.

Positive pay is a fraud protection tool that provides clients with a list of checks. Because check tampering has become a common avenue for fraudsters, clients can match the payees on the list of checks with their own check register and verify that the payee and/or amount has not been changed on the check. Clients can also export their check register via Quickbooks or other accounting software and send it to the bank so they can monitor the checks cleared and alert the client if something is amiss.

SecureLock gives clients control over their debit cards and monitors their credit report.

Sean discussed using debit cards vs credit cards. The advantage to using a credit card is that the money does not come out of your bank account in a fraudulent transaction.

To sign up for alerts, log into your 1st National Bank of Scotia account and then click on Self Service > Alerts.
